## UNITS: PREPARING FOR THE FEBRUARY 5 ELECTION

The pros and cons of the propositions on the February 5 ballot will be presented at the January Unit meetings. There will be seven propositions: Transportation funds, Community College funding and governance, extending the Limits on Legislators' Terms, and four referenda on Indian gambling contracts.

Our League speakers will present the arguments on both sides of the issues and tell you what groups/individuals are supporting the measures. Our totally non-partisan presentations are made before each election.

Feel free to attend any Unit meeting as they will all have the same information – you can work one in around your schedule. (Note that we have a new Southeast Unit which meets on the first Saturday after the Board meeting in the Malcolm X Library.)

At the same time that we present non-partisan information on ballot measures, we often support or oppose them if we have a position that allows that. The League's positions on the February 5 ballot measures have been announced by the California LWV:

### **OPPOSE** Proposition 91:

#### Transportation Funds

*This position reflects the continuing concern about funding earmarks in the state constitution, despite our support for the importance of transportation funding.*

**When was the last time you voted on a referendum? This election should be interesting. Invite friends who are not aware that important issues will be up for voting. Hope to see you there.**

### **OPPOSE** Proposition 92:

Community Colleges: Funding, Governance, Fees  
*This position was a difficult one, as we truly want to see reform of the community college system on the basis of our position adopted in 2003. However, we continue to have concerns about changes to the constitution that would further restrict the ability of the state to continue other important programs in the future. Proposition 92 would set up a designated funding structure without providing new funds and its provisions would be difficult to modify.*

### **NEUTRAL** Proposition 93:

#### Limits on Legislators' Terms in Office

*This initiative, by itself, makes relatively minor changes to the current term limit structure, and without redistricting reform as part of a government reform package, does not achieve meaningful reform. It is moreover involved in an increasingly partisan campaign.*

### **NO POSITION** Propositions 94-97:

#### Referenda on Amendments to Indian Gaming Compacts

*The League has not studied the issues concerning Indian gaming compacts and therefore has taken no position on these measures.*

**Letter from the President**

The fun and games of the holiday season are over. We're now at the starting gate of a politically-charged new year. With election races in February, June, and November, we've got our work cut out for us. As in every election cycle, the public reflexively turns to the League of Women Voters for information and guidance on every aspect of the voting process. And we do our best to deliver the goods -- candidate forums, analyses of ballot initiatives, speakers at community groups, selective endorsement of ballot measures, etc. I hope that one day soon we'll be there delivering the priceless gift of tamper-proof voting machines.

Voters also turn to the League for our public interest advocacy of League principles and positions. In the coming year, we will continue to deliver the goods on open government, charter change, community participation, privatization of city services, education-related issues, natural resources, and recommendations for repair of the city's physical, social, and economic environment. We may sometimes be a voice in the wilderness. But often we do make a difference. Without the participation of LWV on the local stage, our city would be deprived of one of the few civic voices able and willing to speak up for open government and reform.

And speaking of openness, many of you have asked for clarification of the circumstances that led to last fall's leadership changes in the San Diego LWV. Here is some information that should put to rest any residual concerns:

Does the board act in compliance with LWV policy and protocol? Yes. The board adheres to League bylaws, policies, and positions when deciding to take action. We honor our responsibility to keep the voice of the League strong, clear, and honest.

Did the board take a vote of no-confidence in our former president and request her resignation? Yes. The board's decision was necessitated by two critical problems: the demonstrated inability of the former president to maintain a respectful and constructive working partnership with other board members; and the fact that she had taken unauthorized actions, which she attempted to conceal and which would have discredited board members and League advocacy positions.

Does the State League support the leadership changes within the San Diego League? Yes. In a letter to our League, dated 12/16/07, Janis Hirohama, President of the LWV of California, wrote: "... the LWVC recognizes Norma Damashek as the duly appointed president of the LWV San Diego.... We have confidence in the ability of your board and members to move forward in a positive direction and make your League even stronger in the future."

The board and I appreciate this statement of confidence from the State president. We count on everyone's cooperation for the work that lies ahead. To start the ball rolling, the State recently provided the San Diego League with a replacement MTA (management training advisor) whose name is Xandra Kayden. Her experience, impartiality, and independence will be welcome assets to us as the new year unfolds.

The board has already established a nominating committee to begin the process of creating a slate of nominees for our June general meeting. You are encouraged to start thinking about suitable people to serve on next year's board. We will publish contact information for the nominating committee in the February Voter so you can relay your recommendations. And as we do each year, a bylaws committee will be created to keep up with new requirements from the State and National Leagues and, wherever possible, to replace "legalese" with crystal-clear guidelines and verbiage.

Last but not least, although the LWVSD is known to be a top State League in terms of membership and action, we could use some improvement. Where? On our website. The possibilities for the LWVSD to create an identity on the internet as the provider of unique services for the San Diego public are enormous. We can and should be the place to which all San Diegans go for information, guidance, and education about voting and all other issues the League takes a public stand on. We have the integrity, intelligence, willpower, conscience, and duty to fill a myriad of advocacy and information gaps in our city. So please call or email me with the names of fun-loving people with 21<sup>st</sup> century skills in negotiating cyberspace. Let it be said that when it comes to the LWVSD, not even the sky is the limit.
