LWVC SUPPORTS SINGLE PAYER HEALTH CARE PLAN IN SB 840
Join the local Chapter of HCA/CA for OneCare-NOW.org campaign

San Diego - The League of Women Voters of California strongly supports Health Care for All/CA's OneCare-Now.org campaign for passage of Senate Bill 840(Kuehl) which provides for universal health insur-

ance for Californians. “OneCareNow” means one plan; one standard of high quality care for all; one risk pool for all residents covered by one insurance fund. According to an independent Lewin Group study the efficiencies achieved by a single payer health system are estimated to save \$8 billion the first year and up to \$343 billion after 10 years by reducing administrative overhead, waste and fraud. The U.S. is the only industrialized nation without a universal health program. We rank #37 in the World Health Organization’s list of nations. Our population is not as healthy as those above us on this list, including Japan, Canada, France, Sweden, Norway and Germany. If this campaign succeeds in California, other states will follow.

The campaign’s goal is to get, in one year, one million people signed up as supporters of the bill, have an event in a different city or town every day for one year starting August ‘06 and raise one million dollars for the campaign. The daily events will focus on education and advocacy for universal health insurance. Activists will reach out to local governments, schools, local leaders, officeholders and the media to grow support. Events begin in small towns and culminate 365 days later in the largest city, Los Angeles, on August 12, 2007. A week later, on August 19, 2007, a huge rally in Sacramento will call for universal health insurance signed by the governor. In San Diego County the first of 21 events was in Ramona on August 30, ‘06 and continue until August ‘07 in downtown San Diego.

SB 840 has gained broad support from organizations like American Association of University Women, The California Nurses Association, the California Physicians Alliance, California Teachers Association, California School Employees Association, Latino Issues Forum and the Unitarian Universalist Legislative Ministry. SB 840 will require a simple majority to pass, but the financing bill, SB 1784, which is still being developed, will require a two thirds majority for passage. Senator Kuehl is working with legislators on the details of this bill.

AUGUST 9, 2006 STUDY CALLS TRANSMISSION GRID CONGESTION “CRITICAL”

In a study of the nation’s electrical grid release August 9, the U.S. Department of Energy found the congestion on Southern California’s transmission system “critical” and called for immediate action to expand the grid to ensure future reliability and improve access to renewable energy. The National Electric Transmission Congestion Study found that, “Southern California needs new transmission capacity to reach generation resources outside the region for reliability, economics, and compliance with the state’s Renewable Portfolio Standard.”

Southern California was one of two areas nationwide identified as a “Critical Congestion Area.” The only other area was the Atlantic coast between New York City and northern Virginia.

The study also highlighted a 2005 California Energy Commission report that identified San Diego Gas & Electric’s Sunrise Powerlink as a transmission project that is needed in the near term to address these problems.

The Sunrise Powerlink would import enough energy for more than 650,000 SDG&E customers, while expanding access to new sources of clean, renewable energy such as solar, wind and geothermal, located in the Imperial Valley.

The Department of Energy’s findings come on the heels of the California Independent System Operation’s (Cal-ISO) recent decision that the Sunrise Powerlink is a needed transmission project that economically solves San Diego’s known reliability problems. The Cal-ISO is responsible for managing the state’s energy grid. SDG&E filed the application for the Sunrise Powerlink with the California Public Utilities Commission (CUC) on August 4. NOVEMBER SMART VOTER IN ACTION

The San Diego County Smart Voter Committee has met to begin coordinating their Leagues’ efforts to ensure maximum participation by candidates and the voting public on LWV of California’s election website, www.smartvoter.org. Representatives at our initial meeting were Nancy McCleary (ILO), Marietta Lassaline and Eddie Cisco (East County), Patrick Coony

and June Rady (Escondido), Muriel Filman (San Diego City), Joyce Joseph (North Coast) and Frances Talbot-White, southern California Smart Voter coordinator.

Smart Voter is a statewide League project that began ten years ago in northern California and gradually moved south. It is financed by Ed Fund monies and managed by a dedicated state team of league members that includes northern and southern California coordinators. Each county league manages the elections in their location with assistance from the LWVC team. Frances Talbot-White, southern California Smart Voter coordinator, orientated the committee to Smart Voter at the committee meeting.

The Smart Voter website provides free space to all candidates before elections. The format is colorful, readable, and easily found by voters who increasingly use the Internet for election information. The space is configured so that candidates or their assistants are guided through steps to help them put their own information on the site. They can include position papers, lists of supporters, photos, and links to their own websites. Smart Voter also contains long and short versions of state and local propositions, links to local government sites, news media sites, the Registrar of Voters site, an election calendar, and much more. On San Diego County's home page, a voter can enter his voting address, see his own ballot and can then obtain more information on individual candidates and propositions.

In early September, after the Registrar of Voters releases the list of certified candidates, all local candidates will be added to the Smart Voter site and letters of invitation and specific instructions will be mailed to those candidates. The Smart Voter committee members will then conduct follow-up contacts to encourage candidates to participate, so voters have sufficient information to make their own informed choices. We're looking forward to many more members being involved once the site is complete.

SAN DIEGO COUNTY BOARD OF SUPERVISORS OBSERVER REPORT

The Chief Administrative Officer's proposed budget for 2006-2008 recapped past performance and set priorities for the future. Most attention was given to successes

and promises to continue working on problems that remain unresolved. There were no members of the public present on the day of the presentation.

The budget is balanced with a "healthy" reserve. The \$4.33 billion total is a modest growth from 2004-06. The CAO hopes for acquisition of open space, new libraries, health facilities, and better emergency response. The past two years have seen major changes in cooperation and communication technology among those agencies responsible for fire, flood and earthquakes.

The Board continues to pursue consolidation of all unincorporated fire districts. This is being investigated by the Local Agency Formation Commission but is stalled at this point while a funding source is identified. This observer feels that the work already done by the fire districts, fire chiefs and county staff has greatly reduced the danger. All agencies have agreed that individual responsibility is a key factor and have begun educational programs.

A public hearing was held on August 2 on the General Plan 2020 Circulation Element. This has been updated to 2030 because the zoning element build out will demand plans for traffic futures. A good presentation was given by Ivan Holler of the San Diego County Planning Department with maps, graphics and road designations, cost savings, etc. This hearing was well attended by the public and at 3 p.m. the Supervisors were creating a detailed motion that included at least second looks at problem areas (mostly North County and Rural East County).

On August 8 Supervisors voted to support Proposition 1A. It does not add new bonds but assures transportation taxes will be spent on transportation. They did not vote to support Propositions 1B through 1E which create new capital improvements. They supported AB 17 (Koretz) for a Universal Waste District for toxic wastes. There was a report on plans to deal with a flu pandemic from members of all affected organizations, cities, businesses, etc. All except the City of Sa Diego have integrated their own plans with Health and Human Services and the Office of Emergency Services. Watch for your copy of disaster preparedness. It's YOUR JOB. There were also presentations from the Airport Authority and the Marines on multi-use of Miramar. While Supervisors indicated personal choice, there was no attempt to endorse or oppose.

The Board continues with a conservative mindset, with many actions passing on the consent calendar with the support of all five.
