## **MESSAGE FROM THE NOMINATING COMMITTEE CHAIR:**

### **50 YEAR MEMBER**

Donna Jean Meyer joined the League in San Antonio and then moved to Point Loma. Donna Jean was a fifth grade teacher at Kate Sessions School for many years and taught Great Books. She trained as a nurse and then got a degree in education after she moved to San Diego. Donna Jean served as a Unit leader in Point Loma in the days when there were three Units in Point Loma. She worked on government issues in the League and continues to be active in church and women's groups.

### **EDUCATION COMMITTEE MESSAGE**

The Education Committee has been meeting at least once a month and has been focusing for the last few years on educating ourselves and advocating for early childhood education. We have met with all School Board members of San Diego City Schools, the Superintendent, Deputy Superintendent and the area superintendents, and other district staff associated with early childhood education. The School District is now a Pre-K through 12 district and has been including Pre-K in meetings and inservices. Much of our work will culminate in our Education luncheon on April 29, 2011, "Closing the Achievement Gap" through strategies associated with early childhood education. We have also been working very closely with our coalition partners, Preschool California, the Economic Development Council and the Early Childhood Education Department of the San Diego County Office of Education and have recently added the local chapter of the American Academy of Pediatrics. Next year we will be focusing more on advocacy and have been scheduling meetings with Supervisor Pam Slater-Price and Assemblyman Fetcher. We welcome interested members of the League to join us
